TERMS & CONDITIONS

- 1) The initial term of this contract shall be _____ through _____. In the event of an early return, client must notify the sitter immediately or will be charged for any visit not cancelled.
- 2) The fee per visit is \$_____ x _____ # of visits, plus any assessed fees. Total = \$_____.
- 3) Payment for new clients or extended care is required up front and must include any additional fees such as holiday fees, etc. Checks and cash are accepted. In the event it is necessary to initiate collection proceedings on the account, Client will be responsible for all attorney fees and costs of collection. Client understands this contract and takes responsibility for prompt payment of fees. Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting pet sitter/company to accept telephone reservations for service and enter premises without any additional signed contracts or written authorization.
- 4) Pet sitter is authorized to perform care and services as outlined in this contract. The sitter is also authorized to seek any medical care if deemed necessary with release from all liabilities related to transportation, treatment and expense. Sitter is authorized to approve medical and/or

emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse sitter for any expenses incurred attending to this need.

- 5) In the event of personal emergencies or illness the Pet Sitting Service and sitter reserve the right to arrange for qualified persons to fulfill contract responsibilities. The client will be notified.
- 6) In the event of inclement weather or natural disaster, sitter is trusted to use best judgement in caring for pet(s) and home. Sitter/company will be held harmless for any consequences related to such decisions.
- 7) The client is responsible for any costs/payments due to bites, exposure of ailments, diseases by the owners' pets in which they were not properly vaccinated. Cloth choke chain will be provided as a back-up collar.(for protection in case a snap collar should become loose, break, etc) If not provided client must initial here _____initial please
- 8) Client agrees not to hold the service responsible to any injury caused to pet, sitter or general public due to the pet being off-leash at owner's permission in the agreed upon areas during the agreed upon times. If client gives permission for dog to be off leash please initial here.

- 9) Sitting Service and sitter reserve the right to terminate this contract at any time before or during its term, if sitter, in its sole discretion, determines that a client's pet poses a danger to the health or safety of the sitter. If concerns prohibit the sitter from contract obligations, Client authorizes the Sitting Service to arrange for the pet to be placed in a kennel facility at the owner's financial responsibility.
- 9) Cancellation policies:
 - Cancellations more than 24 hours in advance will be honored. If cancellations occur with less than 24 hours notice, cancellation fees equal to the price of the visit may apply.
 - Overnight care longer than 2 days requires 1 week cancellation notice. Otherwise a \$50 cancellation fee may apply
